Students identified as economically disadvantaged	ELA 31% Math 19%	Many of our disadvantage students need small group intervention. We provide this through WIN time, small group instruction by individual classroom teachers.
Students with disabilities	ELA 11% Math 6%	We will continue to support this group of students with daily small group intervention. This intervention is provided by Special Education teachers and qualified paraprofessionals. Special Education teachers are goalsetting to have equitable growth with the General Education population.
Students identified as English learners	ELA 4% Math 3%	We will provide ongoing small group intervention through our ESL program of additional instruction. This small group intervention/collaboration is daily for 15 minutes for each grade level. For our most At-Risk students in this category, we also provide one on one intervention several times a week. We provide Imagine Learning to all students in this category for 20 minutes daily.

A complete adaptation of high level Tier One instruction. These strategies will include the use of manipulatives, visual learning strategies, and the "I do, you do, we do" model. We will intentionally discuss these specific subgroups during our grade level data reviews to identify further intervention processes.


